TERMS & CONDITIONS OF HIRE

These are the terms & conditions of BoroBouncers. Please read these carefully & sign at the bottom to signify that you acknowledge & accept these terms & conditions.

Borobouncers accept NO responsibility for damage or injury whilst our equipment is under hire to you. Please ensure the delivery driver/s has free & easy access to erect the inflatable onto a clean flat lawn.

Please be advised that if we arrive & there is insufficient space or the area is unsuitable (e.g. sloping, unclean or overhanging trees/bushes) full payment still has to be made. Cash on delivery is to be the method of payment.

Borobouncers reserve the right to cancel any booking at anytime (e.g. very bad weather) if more than light shower we may cancel for safety reasons.

1. Inflatables are strictly for children under 14 years old. Under NO CIRCUMSTANCES should adults enter the inflatables as this may result in damage. Any damage will have to be paid for by the hirer named on the agreement. The driver is to be paid upon delivery of the unit, deposits are non refundable. Late cancellations are to be charged at the rate of 50%. NO signs are to be hung/glued onto the inflatables at any time!
2. You (The 'Hirer') are responsible for injury or damage occurring whilst the equipment is on hire, & you are strongly advised to take out Public Liability Insurance covering the use of the unit whilst on hire to you.
3. You must ensure that there is adequate adult supervision at ALL times whilst the unit is in use. The unit cannot be left unattended. If hired overnight ALL equipment on hire is to be stored indoors. When not in use, the castle is to be covered with additional covers supplied by us.
4. Children MUST remove their shoes before using the inflatable/s. they must also be prevented from climbing the walls/barriers for their own safety. Food, drink, glasses, belts & pets are forbidden on ALL inflatables.
5. The 'Hirer' is responsible for safe keeping of the inflatable/s & will be charged for any damage caused to it, or any missing items upon collection.
6. Equipment returned in a dirty condition will be subject to a cleaning charge, No children with face-paints on can use the inflatable/s due to staining.
7. All inflatables will be checked upon delivery & collection, & your signing the T&C indicates acceptance of the inflatable/s as being in good, clean condition.
8. Only our delivery driver/s is authorised to collect our equipment. Under NO circumstances should any equipment be handed over to anybody else.
9. Extreme caution is to be taken with extension cables (which are to be safely tucked away/taped down by the 'Hirer') The blower (fans) are not to be covered with anything at all.
